## 2. COMPOSITION / INFORMATION ON INGREDIENTS.

DEFINITION/BOTANICAL ORIGIN: The volatile oil obtained by steam distillation from the leaves & fresh flowering tops of the shrubby perennial *Rosemarinus officinalis* L. (Fam. *Labiatae*).

## 3. HAZARDS IDENTIFICATION:

R10 Flammable

## 4. FIRST-AID MEASURES:

INHALATION: Remove from exposure site to fresh air. Keep at rest. Obtain medical attention.

EYE CONTACT: Rinse immediately with plenty of water for at least 15 mins. Contact a doctor if symptoms persist.

SKIN CONTACT: Remove contaminated clothes. Wash thoroughly with soap & water, flush with plenty of water. If irritation persists, seek medical advice.

## 5. FIRE FIGHTING MEASURES.

EXTINGUISHING MEDIA Use CO<sub>2</sub>, Dry Powder or Foam type Extinguishers, spraying

SPECIAL MEASURES: Avoid vapour inhalation. Keep away from sources of ignition. Do not smoke. Wear positive pressure self-contained breathing apparatus & protective clothing.

CLEANING UP METHODS  
FOR SPILLAGES:

Remove all potential ignition sources. Contain spilled material. Cover with an inert or non-combustible inorganic absorbent material, sweep up and remove to an approved disposal container. Observe state, federal & local disposal regulations.

## **7. HANDLING & STORAGE.**

PRECAUTIONS IN HANDLING:

Apply good manufacturing practice & industrial hygiene practices, ensuring proper ventilation. Observe good personal hygiene, and do not eat, drink or smoke whilst handling.

STORAGE CONDITIONS:

Store in tightly closed original container, in a cool, dry & ventilated area away from heat sources & protected from light. Keep air contact to a minimum.

FIRE PROTECTION:

Keep away from ignition sources & naked flames. Take precautions to avoid static discharges in working area.
